We are anticipating that thousands of Girl Scouts, including many alums and community partners, will join the celebration thanks to the hard-working committee that started planning this celebration at the beginning of 2020.

GSSNE’s Board of Directors is very proud that our council has secured a \$300,000 grant from the Champlin Foundation to build a brand-new pavilion at Camp Hoffman in honor of this milestone—we anticipate its completion in time for summer camp 2020! In 2019, thanks to another Champlin grant, we were able to build changing stations at our camps. This was most important because campers expressed that they wanted more privacy when changing in and out of their bathing suits. We appreciate all feedback from both girls and volunteers and are very thankful for supporters who enable us to take action on what members want and need.

Additionally, we received feedback from our membership on making our Program Guide more user-friendly and we listened. We received a great response to the re-designed 2019 Guide!

Also new in 2019 was our first-ever Service Unit Manager’s retreat! Thanks to every Service Unit Manager who co-created, with board members and staff, the new metrics for earning the President’s Award. This award is presented in recognition of outstanding service by the volunteers in a service unit for achieving their goals and objectives.

As always, thank you for your commitment to developing girls of courage, confidence and character who make the world a better place by being the role models of our mission and lifting girls up to do the same. This is important work and we are proud to partner with you in making GSSNE a stronger council for everyone. Enjoy this look back on 2019.

Highlights

GSSNE Centennial

On December 2, 2019, Girl Scouts of Southeastern New England celebrated 100 years! Our Centennial Patch Celebration in September was attended by 100 girls, all of whom earned patches to celebrate this momentous event. In total, 340 Girl Scouts earned the Centennial Patch! We ended our Centennial year in December with virtual celebrations so all Girl Scouts throughout Southeastern New England and across the world could celebrate with us.

Toyota Partnership

During the 2019 troop year, GSSNE partnered with the Toyota Boston Region and Toyota Financial Services to create and host programs to build girls' financial literacy and entrepreneurial skills while also aiming to inspire them to pursue futures in business and science, technology, engineering, and math (STEM). GSSNE and Toyota are proud to partner in a combined quest to motivate and inspire more young women to pursue their futures in business and STEM fields. During the troop year, and through this partnership, 80 local Girl Scouts earned their Business Planning, Marketing, and Research and Development badges. GSSNE thanks Toyota for their continued enthusiasm and commitment to the future businesswomen of tomorrow!



New Badges and Programs

In September 2019, GSSNE announced GSUSA's release of 42 badges and one Journey for girls K-12. The badges focused on space science, cybersecurity, outdoor adventure, and coding. Many of these subject areas will give girls the tools and confidence necessary to take on career paths in industries where girls are highly underrepresented. This year, GSSNE offered three Signature Programs catered to each age level of girls, opening a wide variety of opportunities for them to earn these new badges.

The new Girl Scout badge programs have helped girls move beyond their comfort zones, develop agency, and build their confidence! Among these badges are twelve new Outdoor High Adventure badges that feature, for the first time in Girl Scouts' history, two different activity options, letting girls choose how they want to earn each badge! GSSNE offered *Chill Factor: Daisy Snow or Trail Adventure* to allow girls a chance to play in the snow or explore the outdoors.

Eighteen new coding badges have been created, which not only teach girls the basics of coding but also detail how every stage of the coding process provides girls with opportunities to use their skills to help others. GSSNE opened an exciting Signature Program, *Coding for Good*, where Juniors learned about women in computer science, how to create algorithms, how programmers write computer programs, and how people can use computers to help others.

Three Space Science badges have also been developed for Cadettes, Seniors, and Ambassadors, through which girls explore topics such as the universe and their place in it, properties of light, and inspiring careers in space science. *Space Science* is also being offered as a program to explore the mysterious world of Space, learn how we make impactful discoveries, and how girls can be a part of NASA now and in the future.



Summer Camp

Summer 2019 was full of excitement and outdoor adventure! A total of 770 girls attended day camp across our programs at Camp Cookie, Camp Promising Acres, Camp Green Forest, and Camp Rocky Farm.

Day campers unleashed their inner Girl Scout strength and participated in canoeing, kayaking, and archery, built their own fires and cooked outdoors, all while making new friends and life-long memories.

At Camp Hoffman, 373 girls enjoyed the overnight camp experience which included sailing, archery, arts and crafts, campfires, and ascending the high ropes course. Girls learned all the skills needed to complete a successful week of sleeping at camp in platform tents with both new and old friends.

During this camp season, we were once again successful in attaining our American Camp Association (ACA) accreditation, which means that our camps comply with more than 300 industry-established standards in health, safety, and programming.

Camper feedback from the summer was very positive and has helped to mold decisions as we make plans for the summer of 2020. Overall, campers enjoyed their time at camp, but wanted more activities and improved facilities. With this in mind, we will be offering new program themes at all of our camps, and we will be adding an optional Thursday Overnight at all of our Day Camps. For the majority of our camp programs, girls will be able to earn a badge at the end of each week to help prepare them in achieving their Highest Awards.

Champlin Foundation

Our sincerest thanks to the Champlin Foundation for supporting several projects at three of our camps—Camp Hoffman, Camp Promising Acres and Camp Cookie. Each camp has a new 13 stall changing shelter which provides much needed privacy for our campers. This has been a voiced concern of our girls and we listened! In addition, Champlin also provided support so we could build bouldering walls which teach balance, strength and problem solving. And they are fun! A new golf cart was purchased for Camp Hoffman to help our resident campers on move in/out days, get injured girls to our nursing facility, and in the evenings, conduct nightly security rounds of the grounds for the safety of our campers and staff. Lastly a new composting bathroom facility was built at Camp Cookie. Thank you, Champlin Foundation!

2020 Sneak Peak: New Pavilion Project at Camp Hoffman

We are thrilled to report that work is underway to build a new pavilion at Camp Hoffman. The pavilion will be an incredible asset to the way programs and outdoor education are delivered to our girls. It will accommodate up to 80 people and can be used during summer camp and troop camping! We are eager to share much more with you in the coming months but are grateful to the Champlin Foundation for making this significant project possible.



HIGHEST *Awards*



On May 26, 2019, GSSNE celebrated Girls Scouts who earned the Bronze, Silver, and Gold Awards at Roger Williams University at our annual Shine Ceremony. These awards represent the highest honors a Girl Scout can earn and help her stand out as a community leader both now and in the future.

Annually, GSSNE presents the Young Woman of Distinction Award to a local Gold Award Girl Scout whose Gold Award project demonstrated a clear vision, resolve, and commitment to making the world a better place. In 2019, Gold Award Girl Scout Courtney Wegrzyn was GSSNE's local Young Woman of Distinction and received a \$1,000 scholarship towards higher education. Additionally, each year, GSSNE nominates several Gold Award Girl Scouts to be considered for the Girl Scouts of the USA National Gold Award Girl Scout honor (previously known as the National Young Women of Distinction).

Mary Lafferty Celebrates her 100th

Birthday

Girl Scout alum Mary Lafferty celebrated her 100th birthday in style with family and friends at Chapel Hill Senior Living Center in Cumberland on August 26, 2019. Mary, a former schoolteacher in Providence and Central Falls, was a Girl Scout as a child, a Golden Eaglet recipient, and a troop leader for many years. She also worked as a Girl Scout Camp counselor for eight years and says that her “time at camp were some of the best summers of my life!” Along with her family, Mary was also joined by Cumberland Mayor Jeff Mutter who gave her a citation in honor of her 100th birthday. GSSNE staff members including CEO Pam Hyland, former CEO Jan Feyler, and Senior Director of Advancement Ginger Lallo presented her with a commemorative Girl Scout scarf. Mary said that the greatest lesson she learned in Girl Scouting is that “everyone is equal, and all deserve to be heard”. What a beautiful thing for Mary to have learned from Girl Scouting—just think of the many children whose lives Mary touched at camp and throughout her years serving as an educator. Mary made sure that each child was heard and there is no greater gift than knowing that you and your ideas matter! What a wonderful example of a proud Girl Scout alum!



Julia's A-ha Moment

To say Julia was reluctant to join Girl Scout Troop 3179 in Providence at the beginning of the 2018-2019 school year, is a major understatement. She was challenging, disruptive, uncooperative, and generally disinterested in participating whatsoever. A teacher from the school, Ms. Rodriguez, was the Troop Leader of the Junior group of 4th and 5th graders and despite her best efforts, couldn't figure out how best to inspire young Julia to become a team player. It wouldn't be until the troop started working on the Inside Government Badge that things would change for Julia. She was learning about local community council leaders in Providence including an especially inspiring story about Councilwoman (now City Council President) Sabina Matos of Ward 15. Matos migrated from the Dominican Republic with her family and is the first Latina to hold the position in the city of Providence's history. Throughout the badge earning process, Julia learned about other strong leaders like Matos and through that knowledge, learned what it meant to take initiative and ignite change in a community...and, the world. While Julia became more engaged with her Girl Scout troop, she also became more engaged at home and in the classroom. Her teachers were thrilled with her participation efforts and her grades increased exponentially.

“Giving the girls the space and opportunity to be themselves on an equal level playing ground helped them truly open up and develop their own courage and confidence to become independent and strong young women. It's an exciting transformation to witness throughout the year,” said teacher and Troop Leader, Ms. Rodriguez.

The Girl Scout experience made a profound impact on Julia's life—her positivity, drive to

succeed, and overall leadership development seemed to change overnight.

And then...Julia had an a-ha moment!

SHE could showcase the work she and her fellow Girl Scouts had done in their own community throughout the year and celebrate their accomplishments together, in a public forum with their family, friends, and community. It was no small task for this ambitious Junior Girl Scout to take on. It required gumption, hard work, and dedication to see the task through. It was a huge success with over 100 people in attendance, and the girls directed it all: from creating the invitations, to coordinating the menu for a potluck; from DJing the music for the perfect dance mix,

to hanging a gallery display of original art pieces by these renaissance girls, to the badge work and certificate completion ceremony. It was a night to remember, and all orchestrated by our ambitious underdog, Julia. She coordinated, delegated, and problem solved throughout the whole process from inception to completion. Quite impressive for a Junior Girl Scout. If that's not a great example of the power of Girl Scouting, we're not sure what is.



Inspire, Imagine Innovate

In mid-November, GSSNE celebrated 102 years of Girl Scouts selling cookies with a kick-off celebration. Over 100 dedicated volunteers gathered together over breakfast to hear about the amazing accomplishments achieved by our girls, parents, and volunteers that are made possible by the Girl Scout Cookie Program. They were also greeted by the 2019 Honorary Cookie Chair, Alexandra Curtis, who shared words of inspiration along with the new and exciting things that were happening for the 2019 Girl Scout Cookie Season. Allie is not only a Girl Scout alum, but a member of the Rhode Island National Guard, Former Miss Rhode Island, and a GSSNE Leading Women of Distinction honoree.

In January, almost 600 volunteers, girls, and family members took part in the Annual Cookie Rally! The event featured a variety of hands-on activities to help prepare girls for the Cookie Program. These activities focused on the 5 Essential Skills that girls learn by participating in the Girl Scout Cookie Program: Business Ethics, Money Management, People Skills, Goal Setting, and Decision Making.

In 2019, GSSNE, along with many councils nationwide increased the price of cookies. This was GSSNE's first price change in the last eight years, increasing to \$5.00 for the eight standard varieties and \$6.00 for the gluten-free cookie. Just as our daily costs have continued to increase, costs associated with the cookie program have also gone up. With this new change we were able to increase the amount of proceeds to troops and offer new service unit proceeds to be used for bridging ceremonies, activities, and more!

In 2018, ABC Bakers launched a new platform for managing the Cookie Program called ABC Smart Cookies. This platform continues to be improved upon, and in 2019, they introduced the option for girls to take credit cards through the app on their phones when they deliver cookies to customers!



ABC Bakers also introduced the Gluten-Free Caramel Chocolate Chip cookie. This new chewy, gluten-free cookie has rich caramel, semi-sweet chocolate chips, and a hint of sea salt and are produced in a special gluten-free and peanut free facility. At GSSNE, we sold through the 6,480 packages we ordered for in-person sales within the first week and we sold an additional 386 packages through Direct Ship!

Each year, GSSNE selects a local organization to be the recipient of the annual Cookie Program Community Service Project to teach girls the importance of giving back to the community and to learn more about other non-profits in the area. Troops can choose to donate a portion of their proceeds to the organization. In 2019, Little Rhody Rescue was chosen to be the recipient. Little Rhody Rescue is a 501(c)3 non-profit dog rescue and quarantine facility located in Rhode Island that strives to find safe homes for underprivileged and neglected dogs. Troops donated \$2,968.30 to this worthy cause!

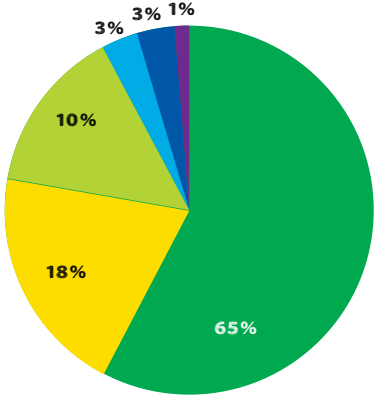

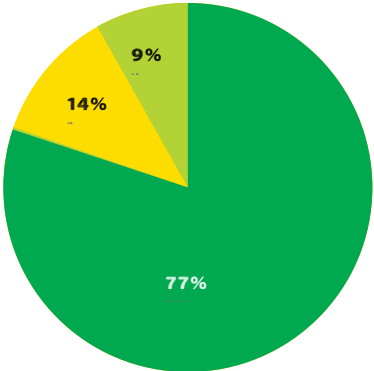
